#### V. New Business

- A. Treasurer's Report Sue Woloszyk
  - a. Education Fund as of 10/31/13
    - 1. 73 judges are eligible for reimbursement by 12/31/13.
    - 2. 26 of the 73 have completed full reimbursement.
    - 3. 20 of the 73 have submitted a portion of their reimbursement.
    - 4. 18 of the 73 have not submitted any reimbursement requests.
    - 5. 9 judges have lapsed memberships and have forfeited reimbursement.
    - 6. Education fund reimbursement must be requested by 12/31/13.
    - 7. Explained that a member is eligible to receive reimbursement from the Education Fund in 2017 if they work 50% of the Judges Cup sessions over the four year period.
  - b. Restricted Fund/Professional Benefits as of 10/31/13
    - 1. There were three members who had overpayment errors from the previous Treasurer which will be rectified by the end of this year's Judge's Cup.
    - 2. There are 55 judges with balances.
    - 3. There are individuals who are no longer members and have balances.
    - 4. Member statements will be sent on a rolling basis each month with one-third of the membership receiving statements followed by the second one- third the next month and the final third in the third month.
  - c. General Fund as of 10/31/13
    - 1. Computer was purchased and new software was loaded to track the budget.

- 2. The Tri-Report will be sent to the RJD by 11/10/13.
- B. Administrative Assistant Report Kathy Krebs
  - a. Members must log onto the National NAWGJ site, nawgj.org, and enter their rating in their personal information.
  - b. Copies of member's rating card, NAWGJ payment receipt and USA Gymnastics membership card with expiration date, safety date and background date should be sent to the Administrative Assistant.
  - c. Ethics Chair News
    - 1. A job description will be sent to the membership.
    - 2. Any non-board member may express an interest to serve with the Ethics Chair to resolve Ethics concerns.
- C. Judges Cup Report Brooke Bennett
  - a. Discussed the venue, food, uniforms, scoring system and general organization.
  - b. Requested suggestions to improve next year's Judges Cup.
  - c. The general consensus of members is that judges who are evaluating routines should wear the official uniform.

  - a. Explained the State Series assignment system.
  - b. The State USA Gymnastics Chair and the State Judging Director do not vote on judge candidates.
  - c. Explained that an effort will be made to increase the judge panel to 4 judges at the L9-10 state meet next year.
- E. Assigner's Report Christi Kerns/Mary Lou Ackman
  - a. Assigning has been completed through January 2014.
  - b. A couple of members are having difficulty using the assigning system.

c. Assigners expressed an interest in using a different assigning system.
