  - A. Linda received a request from USA Gymnastics for the Illinois NAWGJ Board to provide financial support for volunteers to L10 Nationals.
  - B. The Board discussed the possibility of providing financial assistance for both Level 10 Nationals in Indianapolis and Level 7/8 Regionals which will be hosted in Bourbonnais. Illinois.
