Education Corner – Kathie Gebhardt

Level 6 must have a Dance Passage of a min. of two different group 1 elements directly or indirectly connected with one leap requiring a 180-degree split either cross or side position. If they do a split leap, assemble, stretch jump this does not fulfill the requirement as the assemble and stretch jump are not from group 1. Therefore, there is no Dance passage requirement.

Also please watch the Bronze floor when the kids do a round-off backward roll for one of the requirements. Some are doing a round-off, tuck jump, full stop and then the backward roll. Some also do Round-off rebound that looks like a tuck jump but maybe just a rebound with bent knees (as they may not be aware they are bending their knees.) to the backward roll. Benefit to the gymnast and take for bent knees in the rebound.

The following Situations and Rulings were submitted to Kathie Gebhardt by Tracey Rogers for the purpose of adding supplemental explanations to situations that happen in meets.

Situation:

An entire team opted to wear black shorts over their leotards. Several of the girls had rhinestones emblazoning the manufacturer's logo. The coach stated that the judges at the previous meet did not say anything about the shorts. Ruling: The gymnasts were issued a warning for inappropriate attire on their first event. Comment: Correct procedure. Page 20 of the 2021-2022 Rules and Policies (10.a.5) states "Shorts: must be solid black (small manufacturers branding allowed) with no embellishments.
