Reminders from your SJD...

As season takes off, just a few reminders on assigning, preparation and professionalism.



ASSIGNING

- Please remember to keep your availability up to date in GymJas as there are still some weekends that are being assigned/problem solved.
- Use preference to indicate which meet you'd prefer to judge. Selecting multiple meets for the same weekend does NOT indicate a preference.
- Use the comments section when you are available, but know you will be getting assigned elsewhere (i.e. out of state, regional, national)
- The expectation is that you will accept/create contracts within 2 weeks of receiving the assignment. If there is an issue, then reach out to the assigning committee immediately. Do not wait for them to reach out to you; they already have enough work.

PREPARATION

- Be sure to keep all your materials up to date.
- If you haven't judged an event this year, double check all the updates/changes even at the compulsory levels as there have been changes.
- Don't forget we have an entire new level in the Xcel program. Recent issues of the IN include links to this year's updates and are available on ILNAWGJ.com
- Please remember to wear your uniform, when required.
 If it is a theme meet, ensure that what you have selected is youth sport appropriate.
- If something different, unusual or crazy happens at a meet, please consult with your meet referee before taking action. If they don't know the answer, then they should reach out to SJD. It can be helpful to share these incidents, so that others may learn and/or we can find an answer from USA Gymnastics/NAWGJ.

PROFESIONALISM

- Remember the <u>NAWGJ Code of Professional</u> <u>Responsibility</u> while at a meet. You are representing yourself, NAWGJ, Illinois and Region 5.
- No cell phones at the judging table. (If an emergency arises, please leave competition area briefly and communicate with meet ref)
- If you are judging on an iPad/tablet it should be in airplane mode.
- Speaking with coaches should be minimal and limited to quick answers. If you are needing to explain an entire routine they should be submitting an inquiry.
