Among the women and men scheduled to compete in the 2024 Xfinity U.S. Gymnastics Championships:

- They collectively have won 92 medals in Olympic or World Championships competition, including 15 Olympic medals and 77 World Championships medals
- They also have won 27 medals at the Pan American Games
- 13 athletes Olympic team members (8) or alternates (5)
- 23 World Championships roster members
- 20 athletes have won medals at either the Olympic Games or World Championships
- 16 athletes have won a combined 65 U.S. titles


